spectacular event was organised to launch 'Diamonds are forever, so are morals', an autobiography of Shri. Govind Dholakia, India's 'numero uno' diamond baron and philanthropist, on Thursday, the 15th of September, at Crowne Plaza, Kochi in the presence of academia, entrepreneurs, managers, management students and intellectuals of God's Own Country. The well-attended event was organised by the Kerala Management Association (KMA) jointly with TIE Kerala and The Indian Society for Training & Development (ISTD).

It is true, Shri. Govind Dholakia's story is that of 'rags to riches', but it is uniquely different. There wouldn't be a business person in the country who did base his enterprise completely upon moral values and spirituality as Shri. Dholakia did.

The spirituality element prompted him and his enterprise to have compassion for others, particularly those belonging to the lower strata of society.

KMA's connection with Kakaji (as Shri. Dholakia is reverently addressed) goes back some years. He came to Kochi to address its CEO Forum earlier. He also partially sponsored the renovation of the KMA building last year. So when the association realised that his autobiography had been launched, it requested him to please launch it in Kochi, and he gracefully acceded to the request.

The function started with the lighting of the lamp in the presence of the leaders of the participating organisations, Shri. Govind Dholakia, Shri. Kamlesh Yagnik - the coauthor; by our beloved Member of Parliament Shri. Hibi Eden. The MP

also spoke about the spiritual basis of Dholakia enterprises and the yeomen services rendered by Kakaji to the people, industry, state and the country.

KMA President Ms Nirmal Lilly delivered the presidential address. Mr Dinesh Thampi, the Chairman of the ISTD Kochi Chapter, introduced Shri Dholakia to the audience.

The book was launched jointly by M/s. Hibi Eden, Govind Dholakia, Kamlesh Yagnik, Nirmala Lilly, Dinesh Thampi, Damodar Avanoor (Sr. VP, TiE:Kerala) & SR Nair, the moderator of the show.

Mr Kamlesh Yagnik, the co-author instead of reading the book, dwelt on the essence of the book, its genesis, its relevance, the special features and about the values that helped Kakaji lead the SRK enterprise with aplomb.

In the next half an hour, a conversation took place between Kakaji and SR Nair on the content of the book. In his own inimical manner, Shri Govind Dholakia talked in English, Hindi & Gujarati. The connect between him and the audience was absolute and as he spoke, the audience lapped it up enthusiastically with empathy. There was no need for any translation or interpretation. His direct communication went to their heart straight.

Though many questions were answered, two very interesting aspects of his life need special mention:

One was him attending a discourse by Shri. Dongreji Maharaj, based on the advice of the seer, him taking an instant decision (at the age of 17) to address everyone, irrespective of age or position, with the utmost respect. Kakaji said with pride that thereafter, he was never insulted by anyone!

The second was an emphatic confirmation from Kakaji that in the fifty-five odd years of his married life, he and his beloved wife (Smt. Champaben Dholakia), never had a quarrel. It was an incredible jawdropping moment for the audience.

A visual of the Dholakia clan of around 1500 people, all meeting on



a particular day of October every year at Surat, made the audience stand up and applaud. It is such a close-knit family, and it could even be a record of sorts for every one of it to attend it from all over the globe, this yearly get-together of mammoth size.

Shri. Damodar Avanoor, representing TiE:Kerala, felicitated Kakaji.

Kakaji also gracefully invited Mr Jose Dominic, Mr Geemon Korah & Mr M P Joseph for the IAS officer (retd) to the podium to hand over a signed copy of the autobiography.

The Cochin Gujarati Mahajan felicitated him by giving him a

memento.

The crescendo of the show was the bestowal of the Great Leader award upon Shri. Govind Dholakia jointly by KMA, TiE and ISTD leaders.


Hon. Secretary of KMA Shri. Algiers Khalid proposed the vote of thanks.

Authored by Arun Tiwari (Indian Missile Scientist, Author of APJ Kalam's "Wings of Fire") and Kamlesh Yagnik (President of Sarvajanik University), the book is published by Penguin Enterprise, an imprint of Penguin Random House.

The autobiography revisits a substantial part of Govindkaka's life, struggle and professional journey. With the book, Govindkaka wanted to share his life experiences with all to be reassured that a life of honesty and ethics helps achieve great success and gives immense satisfaction. The simile between morals and diamonds in the title of the book itself sets the tone.

We took a Bus tour to this massive

32-acre park. On the way, we were shown their eco-friendly initiatives of 'nakshathra vanam', which is an area for plants and trees representing 27 stars of Malayalam nakshathras like Ashwathy, Bharani, Karthika etc. Equally interesting was their Miyawaki forest where, in 30 cents of land, they are developing a forest of 300 trees! The commitment of the management on zero emissions was seen by the long solar panels over the car parking areas generating an output of 350 KV electricity.

Our bus stopped in front of a high-end, state of the art lab with facilities that support LC-MS-MS, GC-MS-MS and many more techniques. These are analytical techniques used to identify and quantify low-level analytes and unknown volatile components in solids, liquids and gases. These







and many more similar techniques available at their research labs ensure purity of materials used in processing. The place was spick and span with every staff in their uniform, willing to explain every query we had.

The Kitchen Treasures, a place of aromatic fusion for us and the ultimate friend to many in our kitchen was our next stop. Due to hygiene protocols to be followed, we restricted our entry to the warehouse, where we found huge cartons just waiting to be transported locally and internationally. That is where many of us learnt that chicken masala contains nothing but veg!

Symega food ingredients was our next stop which showed us another world of flavours. They specialize in designing and producing sweet and savoury flavour solutions. Symega does wonders to the cakes we eat, sauces we dip, the pastas we savour, the mayo we lick off our fingers! Felt proud to see many national and international player's logos and product samples displayed on their showcase as their clients. We were accompanied by Mr Jacob Ninan, MD, Herbal Isolates to the various labs where flavours are crafted and customised for different products of multiple companies.

Pepper to us is invariably black or white. We heard about green, red, black & white pepper from Herbal Isolates, our final stop. They bring to the world the aroma and taste of pepper!

Mr.Jacob Ninan, the third generation family member, explained how backward integration works to procure good quality pepper, turmeric and fenugreek and the heat sterilisation technique they use to obtain the best outcome.

A guick peep into taste pyramid and umami-the fifth taste - took us by surprise about the unlimited opportunities in this sector and the untapped potential Kerala has. In school we were all taught about sweet, salt, sour and bitter, but now it is understood that there is one more taste which is umami meaning 'savoury'. This Japanese word describes taste as meaty, savoury and delicious that deepens flavour. The tour came to an end by Mr.Ninan Philip gifting all of us with chocolates and Kitchen Treasures Palada mix. What more can you ask

Not to forget was the sumptuous meal and tea and coffee breaks that were so well integrated into the plan thus ensuring no wastage of time. The simplicity and humility of the whole team are truly inspiring.

May they win more accolades and add more feathers to their cap.

Memoir as President of KMA & AIMA



T. T. THOMAS KMA President 1991-92 AIMA President 2000-01

n the seventies, management was not a well-accepted discipline to pursue, except in IIMs. There was considerable demand from working managers for orientation courses like MDPs, Training programs etc. KMA however had limited space to offer these courses. Therefore, programs were conducted at productivity council hall in Kalamassery or at any affordable hotel. Among them, the International hotel was the favorite place at that time. The guest for an own building started before I became KMA President, However, KMA did not have the adequate resources to go ahead at that time with such a major project. Even the flagship program of annual convention was often hand to mouth and did not generate enough money for building its own KMA house. It all started after getting the land allocated from government authorities with the tireless efforts of many KMA members. Presidents & members then initiated a massive fund collection drive within Kerala and outside. One of the leading companies among them was FACT. They were in the forefront by not only directly contributing a large sum but also through its vast network of associates across south India. I vividly remember, the well-wishers of the management movement of FACT's Marketing network spread from Kanyakumari to Visakhapatnam earnestly participating in the fund-raising effort. From within our state of

After a couple of stints as committee member, I was elected as President of KMA for the year 1991-92. It was a great honour to take the mantle of this prestigious management association which had in the past several stalwarts of FACT like Padmashre Paul Pothen (Secretary 1960-65), Shri MKK Nayar (1960-71), Shri BK Khanna (1971-72), Shri Dr. P.K. Narayanaswamy (1978-79), Shri NB Chandran (1986) etal.

Kerala, we got a large-hearted response to KMA's appeal for funds to build the KMA house from several leading companies. I must place on record the unforgettable contribution by Shri P. Kesavan (President 1983), Shri VN Venugopal (President 1987), Shri KP Philip (President 1989-90), Shri AK Mathew (President 1997-98), Shri N. Sreekumar (President 1998-99), Shri AK Nair (President 1999-2000), Shri MK Koshy (President 2000-01) and all others. One of the major contributors then was Cominco Binani Zinc Limited. I also remember a group of us consisting of Shri George Varghese MD of OEN Connectors Limited, Shri NP Gopalakrishnan (President 1981) and Shri Thomas Oommen (President 1988-89) and myself went by car all the way to Kannur to meet Shri. A.K. Khaderkutty Founder and then Managing Director of The Western India Plywoods Limited. He too then contributed a large sum of money to support our efforts for an own Management house.

Finally, the foundation stone for the Management house was laid by Shri

G. Binani, Chairman of Binani Zinc Limited on 28th July 1991 and the new building was inaugurated by Shri SM Dutta, Chairman Hindustan Lever Limited on 29th May 1993 during the Presidentship of Smt Pamela Anna Mathew (1992-93).

Very many eminent personalities have addressed KMA members during the first part of the new millennium. Some of the luminaries who addressed KMA members were Sam Pitroda, S.M Datta and Mark Tully ex BBC India Chief, the latter released my book 'Story of FACT Ltd: A Study on Public Sector Management'. KMA then had nationally and internationally recognized management professionals who enhanced KMA's brand equity, which is its greatest asset. KMA hosted an AIMA council meeting at Cochin in 2000 with about 20 very senior industry leaders from all over the country attending it. Some of the industry leaders later told me that 'we like Kerala and Keralites, but not its industrial culture'.

One another event, that comes to my mind is a visit to Trivandrum

Doordarshan studio along with then Vice President Smt Pamela Anna Mathew and Dr Ranganathan, Director of School of Management studies, Cochin university. It was long before the cacophony of media discussions by 'experts' that we watch today. Our panel discussion at Doordarshan was on "Industrialization of Kerala, its problems and solutions". Interesting part of this discussion was about the problems and solutions. What was then discussed and brought out still continues to be narrated and discussed even today. Nothing has changed except for grandiose industrial policy announcements by successive governments and marginal changes due to application of IT solutions.

I was elected president of All India management association (AIMA) for the year 2000-2001 at its council meeting held in Calcutta along with the AIMA annual convention of that year. Prior to that, I was Vice-president of AIMA for two terms, representing South Zone in the Council. AIMA at that time had four regional councils North, West, South and East. I was egged on to join the SRC as a stepping stone to the AIMA hierarchy by Shri N.P. Gopalakrishnan, KMA President. for the year 1981.

Election of AIMA President was always by consensus till then. However, in 2000-2001, there was an election for the Presidentship for the first time in the history of

AIMA. The candidate opposing me was Shri Venkataramani, Managing Director of India Pistons, a TVS Group company. There was an attempt by some senior members to dissuade me from contesting. I took counsel from Shri Jose Philip, who was Secretary of KMA in 1998-99 and later became KMA President 2001-02. He was then in Calcutta along with me attending the AIMA annual convention as a delegate. Shri Jose felt that and that I should not withdraw. Afterall, the choice was to be made by the Council members. Eventually after the voting, I was elected with a razor thin margin of one vote. This changed the election eco system for ever.

The year 2000 was very eventful for global business. That was the era of the Y2K phenomenon when the world transitioned from 19th century to 20th century requiring several modifications across the board in existing software. India and Indians became a noticeable software power in 2000, due to their contributions that made the smooth transition to the new millennium.

AIMA and its affiliated I MAs were enablers to conduct seminars and interactive sessions all across the country with senior executives and experts from within and outside the country. This was a challenging mission which AIMA executed very well. It gave a lot of confidence to the participants and the public at

large on the ability of India and the global system to face the challenges of Y2K.

A notable achievement during my Presidency was the establishment of affiliated LMAs outside the country in Indian Ocean Rim (IOR) countries at Oatar and Mauritius. This was a significant effort to consolidate India's soft power in the crucial IOR. The Qatar Management Association (QMA) was inaugurated by his excellency the prince of Qatar and the first President of QMA was Shri Nissar Kochery. I had the great honour and privilege to be present for this inaugural function. A notable recognition that AIMA had given to Kerala in 2000, was the Lifetime Achievement Award to doven of Indian industry and patriarch of Management Education Shri K.T Chandy, Founder Director of IIM Calcutta, which is the first IIM in the country.

Several LMAs were started in a number of cities since post liberalization which gave tremendous confidence and excitement to industry and business in the country. LMAs were allowed to be start only with the approval of AIMA. During my Presidency a new LMA in Orissa wanted to name it as Orissa Management Association. We had a deliberation in the council when a number of members felt that city based LMAs should not be given State name. 'Kerala' in KMA came under the scanner as there was already an objection from one another Kerala based Management Association to KMA calling itself Kerala Management association. The matter was closed when I, as President, pointed out that KMA was functioning even before AIMA.

I am sure in the coming days under the able current and future leadership, KMA will scale even greater heights and glory. My good wishes to the President, MC and all KMA members.
